

## The practical guide for celebrating your wedding

Celebrating your wedding before a notary is an alternative to a traditional wedding officiated by a religious minister or a civil officer.

### 1.) The administrative aspect of the celebration

At the first appointment, you must bring several documents to the notary: your birth certificates, two pieces of photo identification for each of the future spouses, the divorce certificate if one of you is divorced, or the death certificate if one of you is widowed.

The notary will explain the legal implications of marriage and advise you on the choice of the matrimonial regime (the different regimes are explained in detail in our guide, «The Practical Guide

to Choosing Your Matrimonial Regime.» which is also available on our website).

The notary will also issue a marriage notice. This notice must be published on the Directeur de l'État civil's website at least 20 days before the date of the celebration and no more than 3 months before.

This notice contains several pieces of information that you must provide to the notary, listed below:
